KYCC (Koreatown Youth and Community Center) was established in 1975 to support a growing population of at-risk youth in Los Angeles. Today, **KYCC** is the leading multiservice organization in Koreatown, supporting children and their families in the areas of education, health, housing, and finances. **KYCC** is committed to making Koreatown a safe and beautiful place to live and work.

The mission of **KYCC** is to serve the evolving needs of the Korean American population in the greater Los Angeles area as well as the multiethnic Koreatown community. **KYCC**'s programs and services are directed toward recently immigrated, economically disadvantaged youth and families, and promote community socioeconomic empowerment.



OUR TEAM

When the Korean Youth Center was founded in 1975 as a project of the Asian American Drug Abuse Program (AADAP), we only had one full-time staff member and a handful of volunteers. Today, the Koreatown Youth and Community Center has six locations across Koreatown, and a diverse, multilingual staff of over 80.

PREVENTION EDUCATION

Building Stronger Families—Best Start Metro Los Angeles

KYCC is the lead partner for the Building Stronger Families Project, which builds community capacity to address social norms that perpetuate the cycle of violence inside and outside the home. Parent leaders are engaging and motivating communities through the Culture of Respect Pledge Campaign which promotes the values of Respect, Positive Raising of Children, and Equality for All. By promoting and practicing these values, community members can create a safe and healthy neighborhood for children and families.



“I have been disheartened by the piles of regularly dumped trash on the sidewalk near my apartment complex. So many young children live here and the trash is unavoidable if you want to park or take a walk. ENVIRONMENTAL SERVICES

Clean Streets Program – City of Los Angeles Board of Public Works,
Office of Community Beautification

KYCC’s Clean Streets Program works in partnership with the Office of Community Beautification, Council District 1, Council District 10, and the Los Angeles Police Department, Olympic Division to clean the streets of Koreatown, Westlake and Pico-Union. The program has been extremely effective in mitigating the abundance of trash, weeds and other blight.

COMMUNITY ECONOMIC DEVELOPMENT

Volunteer Income Tax Program

For 10 years, **KYCC's VITA** program has trained and worked with local bankers who volunteer their time and energy during tax season to help local low-income residents file free income tax returns. In 2015, 220 volunteers contributed 8,302 hours and assisted nearly 10,000 clients in bringing back \$12.4 million in refunds.





CLINICAL SERVICES

Integrated Care Program

Funded by the Los Angeles County Department of Mental Health, ICP incorporates health, mental health and substance abuse services in a holistic model of care. Clinical Services outreach and educate community members—at high schools, colleges, senior centers, seminars and local festivals—to break down stigma and barriers to mental health services. In 2015, ICP connected with over 200 community members, some of whom receive counseling services from our agency.

KIDS TOWN

Parent Advisory Council

Kids Town's Parent Advisory Council is the liaison between the preschool and families. This group of 10 holds monthly meetings with Kids Town staff and teachers to discuss curriculum, school events and parent concerns. They also recruit classroom volunteers, raise issues around safety and help implement policies and procedures.

MENLO FAMILY CENTER

Universal Dream Team

Universal Dream Team meets weekly at the Menlo Family Center to discuss family and neighborhood concerns, mobilize and activate the community’s strengths, and provide leadership training and resources to Menlo Family Apartment tenants and residents from neighboring communities. Universal Dream Team is one of eight Neighborhood Leadership Groups, under the Best Start Metro L.A. Partnership, and is led by our partner agency Para Los Niños.

PREVENTION EDUCATION

Community-Based Participatory Research

KYCC's Prevention Education launched a Community-Based Participatory Research (CBPR) group this year to understand the impact of alcohol outlet density in the Pico-Union and Westlake neighborhoods of Los Angeles.

This group of 16 women is entirely comprised of Spanish-speaking mothers and grandmothers, many of whom were previously involved in alcohol outlet density-related work with **KYCC** in our substance abuse prevention parent programs.

KYCC VOLUNTEER PROGRAM

Volunteer Team Leader Program

Our new Volunteer Team Leaders are the kinetic force behind **KYCC's** Environmental Services's projects and success. They recruit friends and enlist neighbors to our community cleanups, tree plantings and many other beautification efforts.

ES works with one goal in mind: to beautify the streets of Los Angeles, creating safer, more eco-conscious neighborhoods. Our Volunteer Team Leader Program trains volunteers to be leaders in their community, provides them planting experience with **KYCC's** certified arborists and discusses local environmental initiatives

MILESTONES 2015-2016



STAR TREK BEYOND DONATES \$110,000 TO KYCC

Former **KYCC** staffer John Cho, who plays Hikaru Sulu in the new Star Trek franchises, selected **KYCC** to benefit from a \$110,000 donation from the proceeds of an exclusive Star Trek Beyond charity event, #toboldlygo. By entering a raffle, Trekkie fans won walk-on roles and behind-the-scenes meetings with Enterprise crew members. This campaign—to commemorate the 50th anniversary of Star Trek—was a 2015 partnership between Paramount Pictures and Omaze.



KYCC RESPONSIBLE RETAILER COMMENDED

In October 2015, **KYCC** helped to honor the 8th Street OK Liquor Store in Koreatown for its outstanding commitment to community safety and health. The California State Senate, Los Angeles City Attorney's Office and the Los Angeles Police Department gave certificates of recognition to owner Bong-Ok Lee. Since 2013, 8th Street OK Liquor has been a community partner of **KYCC's** Responsible Retailer Campaign, which addresses the proliferation of liquor stores and its connection to alcohol abuse in Koreatown, Pico-Union and Westlake.



KYCC PROVIDES FINANCIAL COACHING TO VETERANS

KYCC launched an 18-month financial coaching program for veterans at the VA Long Beach from November 2014 to April 2016. This program was part of a workforce development partnership between **KYCC** and the Jewish Vocational Services. By improving personal credit and stabilizing finances, **KYCC** helped to increase employment options and promote long-term job retention for the veterans. Through a grant from the Federal Home Loan Bank of San Francisco, **KYCC** also added matched savings and one-on-one financial coaching for veterans.



KYCC RECEIVES CA DEPT. OF FORESTRY & FIRE PROTECTION GRANT

In September 2015, **KYCC** received a \$330,000 four-year grant from the California Department of Forestry and Fire Protection to work with residents and community groups to plant over 1,000 trees in disadvantaged communities. The focus of the grant is to use engagement activities and incentives to create a full and healthy canopy on as many individual streets as we can. We hope these lush, shaded streets will inspire more residents to plant trees and enjoy the multiple benefits they provide.



KYCC EXECUTIVE DIRECTOR NAMED STANTON FELLOW

In December 2015, **KYCC** Executive Director John Ho Song was awarded the Durfee Foundation’s 2016-17 Stanton Fellowship. As a Stanton Fellow, Song will take two years to travel, research and convene neighborhood stakeholders to draft a Koreatown Community Plan. Prior to the Stanton Fellowship, Song was a 2009 recipient of the Durfee Sabbatical, which offers leaders in the Los Angeles nonprofit community stipends to “travel, reflect and renew” themselves to better serve their organizations.



MENLO FAMILY NIGHT

In March 2016, over 80 families attended “Menlo Family Night,” a family-friendly event that promoted healthy parent-child relationships and strong families. Professional family portraits were taken, and clothing, footwear and school supplies were donated to Menlo schoolchildren. Special thanks to Los Angeles Dodger Hyun-jin Ryu, School on Wheels, Bank of America, Para Los Niños, Best Start Metro LA, the L.A. County Dept. of Children and Family Services, Community Child Abuse Council, and the API Children, Youth and Family Council.



YDAPP HOSTS “HIGH, IT’S ME” YOUTH CONFERENCE

KYCC’s Youth Drug Abuse Prevention Program (YDAPP) hosted the “High, It’s Me” Youth Conference at Vista Charter Middle School in March 2016. Over 60 high school students attended the event to explore their identities and find natural ways of getting “high” through different forms of arts. Established in 1996, YDAPP is a 10-month leadership program that trains youth advocates to raise awareness among Koreatown, Pico-Union, Westlake youth about the risks of substance abuse.



COPALM HOSTS COMMUNITY FORUMS ON ALCOHOL OUTLET DENSITY

As the lead agency for the Coalition to Prevent Alcohol-Related Harms in LA Metro (CoPalm), **KYCC** hosted community forums in East Hollywood and Boyle Heights in March and April of 2016 to discuss substance abuse prevention and control, address the oversaturation of liquor stores in their neighborhoods, and unify in an effort to reduce alcohol-related crimes in the L.A. Metro area.

We seek out neighborhoods with few trees and many hands. **KYCC** beautifies Koreatown and surrounding neighborhoods by leading community cleanups and service projects, and increasing safety by removing graffiti free of charge, seven days a week. Through neighborhood beautification and environmental education, **KYCC** is helping to make Los Angeles a cleaner, greener and more livable city.

Prevention Education is funded by the Los Angeles County Department of Public Health, under the Substance Abuse Prevention and Control division. Our academic support programs supplement school education and foster independent learning through out-of-school-time services for low-income children. 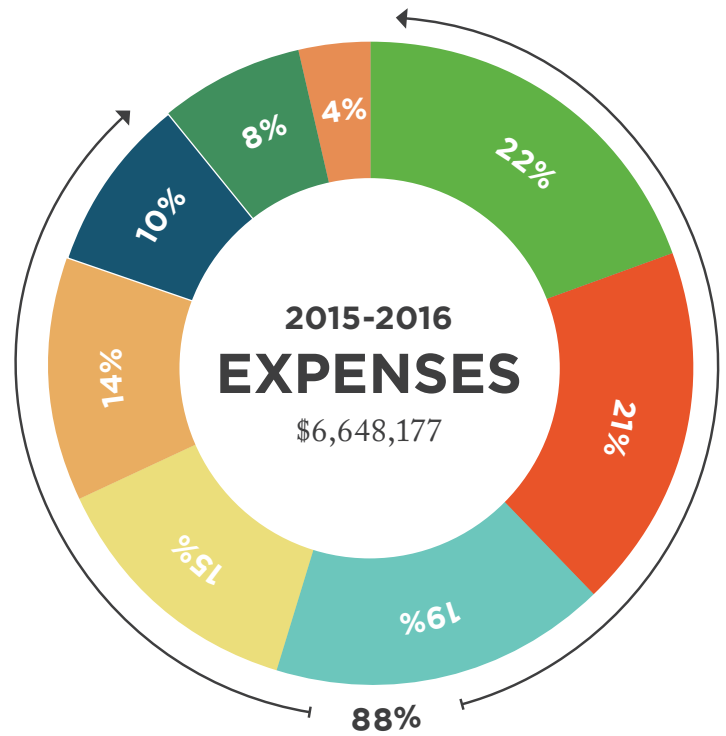
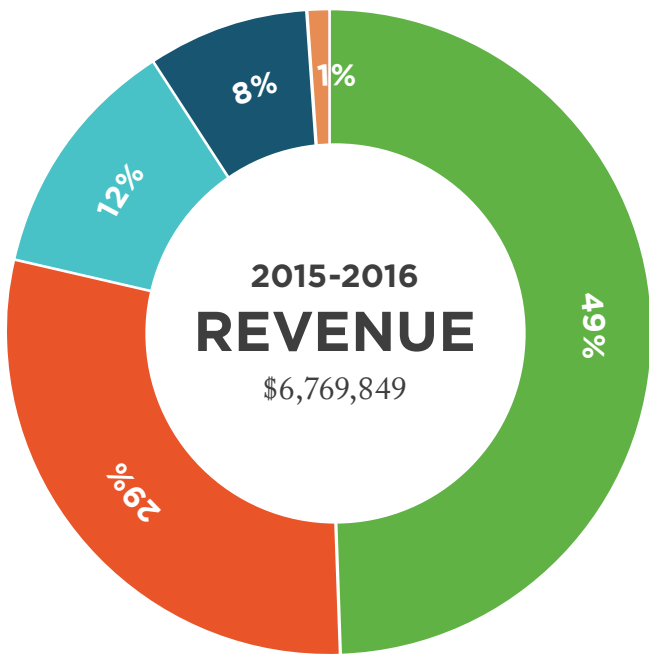

Community Economic Development services and programs focus on building community wealth through helping families achieve financial stability. We offer financial coaching and case management services to provide free one-on-one financial guidance, motivation and advice to help families increase financial capability. **KYCC** owns 209 low-income housing units at 8 locations, providing affordable housing for the residents of Koreatown. Through our Volunteer Income Tax Assistance program, **KYCC** helped almost 10,000 clients file free federal and state income taxes and ensured that those eligible for Earned Income and Child Tax Credits received tax refunds in 2015. Our Small Business Development program provides free technical assistance to small businesses and entrepreneurs to provide economic opportunities in our community. **KYCC** also offers utility assistance programs to help non-English speakers resolve their billing issues.

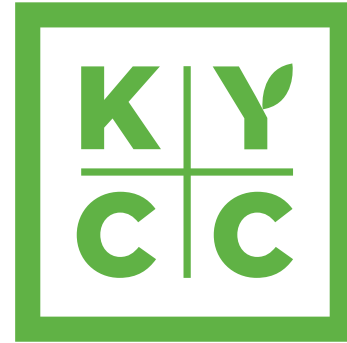
